

#### **COOKIES NOTICE**

#### 1 Introduction

- 1.1 This notice ("Cookies Notice") explains how Astron Energy Proprietary Limited ("we", "us" or "our") uses cookies and similar tracking technologies on our website. It also tells you how this applies to a website user ("you"). We have described what these technologies are, why we use them, and your rights to control our use of them.
- 1.2 To the extent that we process your personal information when using cookies, our external privacy notice ("**Privacy Notice**") is also applicable to you and should be read with this Cookies Notice. #### 2 What are Cookies?

A "cookie" is a small text file sent by a web server to store on a web browser. This allows us to recognise your device and remember certain information about your visit to our website, such as your preferences and actions on our site.

### 3 How and why we use Cookies?

- 3.1 We use cookies to ensure that our website functions properly; it stores user preferences when needed; and collects anonymous statistics on website usage.
- 3.2 Our website may use the types of cookies for the purposes set out below. For more specific details on the cookies we use and how long we retain cookie related data, see Annexure A.

## 3.3 <u>Strictly Necessary Cookies</u>

- 3.3.1 "Strictly necessary cookies" are required (i) for our website to function; (ii) to provide basic features; or (iii) allow access to specific sections of our website. These cookies are usually only set in response to actions made by you that amount to a request for services, such as setting your privacy preferences, logging in, filling in online forms, or completing online transactions.
- 3.3.2 You can set your browser to block or alert you about these cookies, but blocking these cookies may (i) prevent the site from working (ii) give you issues with logging in to our website, accessing secured pages, or submitting forms.
- 3.3.3 Strictly necessary cookies do not process personal information or amount to us monitoring your behaviour for advertising purposes.



#### 3.4 Functional Cookies

- 3.4.1 "Functional cookies" enable our website to provide enhanced functionality and personalisation, such as remembering your preferences or providing you with personalised content. They may be set by us or by duly appointed third party service providers whose services we have added to our pages. Functional cookies would include, for example, your preferences regarding language, login credentials, location settings, and form data.
- 3.4.2 These cookies are not essential for the operation of our website, however if you block them then some or all of your personalised features, including your user preferences or form data, may not function as expected. The website will still work but your user experience will be less tailored.
- 3.4.3 Functional cookies may process your personal information and our use of such cookies is subject to POPIA. Functional cookies are not used for monitoring your behaviour for advertising purposes.

## 3.5 <u>Performance Cookies</u>

- "Performance cookies" collect information about how visitors use our website so that we can measure and improve the performance of our site. More particularly, these cookies also (i) collect data on how you interact with the website, allowing us to analyse and improve our website's performance; and (ii) help us understand how our site is being used, such as which pages are the most and least popular and how people navigate around the site.
- 3.5.2 The information collected in relation to these cookies is aggregated, meaning that they do not relate to you personally. We do not therefore process your personal information in relation to these cookies and they do not monitor your behaviour.
- 3.5.3 Blocking these cookies will prevent us from (i) knowing when you have visited our site; and (ii) monitoring website performance. While this will not affect the website's functionality, it will hinder the collection of data for improving the website and optimising marketing efforts.
- In some cases, these cookies may be sent to third party service providers to help us manage our website analytics. Some specific third parties we use are:

## 3.5.5 Google Analytics

- 3.5.5.1 Our website may use certain Google Analytics features to collect information and report site usage statistics without personally identifying individual visitors to Google. '\_ga' is the main cookie used by Google Analytics. '\_ga' enables a service to distinguish one user from another and lasts for 2 years.

#### 4 Do we collect any personal information?

- 4.1 **"Personal information"** is defined broadly in POPIA and includes any information which identifies you (tells someone who you are), from which you are identifiable (from which someone can work out who you are), or otherwise relates to you. See 5 of our Privacy Notice in this regard. We process your personal information with references to cookies as set out in this Cookies Notice.
- 4.2 Our website captures data about your session, your device and your interactions with ads and content. This information is sent to our systems. This may include your online identifier information which is personal information. Further, the information in any of the forms you complete will also be sent to us, this may include your name and contact details, which is also personal information.

### 5 How do we use your personal information?

- 5.1 We use your engagement data and information on your session for customer support, lead generation or website optimisation purposes. The information on any forms that you fill out may be used by our team for lead management and email marketing purposes.

- 6.1 You may refuse to accept cookies by activating the setting on your browser which allows you to refuse the setting of cookies. However, if you select this setting you may be unable to access certain parts of our website. Unless you have adjusted your browser setting so that it will refuse cookies our system will issue cookies when you log onto the website.
- 6.2 If you accept a cookie or fail to deny the use of cookies, you agree that we may use your personal information collected using cookies. Where you either reject or decline cookies, you are informed that you may not be able to fully experience the interactive features of our website.
- 6.3 You also have certain rights concerning our processing of your personal information in accordance with POPIA. These rights are fully set out in our Privacy Notice, particularly in paragraph 21 thereof.
